24, 86, 91	G22.5 CR App 4 CR App 5	Electronic Devices Dress Rules – HT, watches Tack Rules – Cross Country	<p>No receiving, recording, transmitting or monitoring device <i>other than a watch (for horse trials only)</i> maybe used by a competitor during any phase of a competition. The use of head cams are strictly prohibited at any BRC affiliated competition. This includes use on the head, chest, bridle or any other part of the horse or rider.</p> <p>Stop watches are FORBIDDEN in <i>one day cross-country and FOTH Challenge events only.</i> <i>A watch is permitted for cross country phase of horse trials only.</i> Competitors are NOT permitted to take mobile phones onto the course when competing.</p> <p>Equipment: Watches are NOT to be worn in <i>FOTH Challenge events.</i> <i>Watches are permitted for Horse Trials only.</i></p>	Immediate
